SHAKE WELL BEFORE USING

TO KILL FLEAS ON CATS

Hold the can upright. Spray the animal from a distance of 3-12 inches. Apply at the rate of one second per pound of body weight.

Start spraying at the tail, moving the dispenser rapidly and making sure that the animal's entire body is covered, including the legs and under the body. While spraying, fluff the hair so that the spray will penetrate to the skin. Make sure spray wets thoroughly. Do not spray into eyes, face or genitals. Repeat weekly, if needed. Do Not Use On Cats Under 12 Weeks. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals, or animals on medication.

FIRST AID

IF IN EYES: Flush immediately with plenty of water. Get medical attention if irritation persists.

IF INHALED: Remove affected person to fresh air. Apply artificial respiration if indicated.

IF ON SKIN: Wash contaminated skin promptly with soap and warm water.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry area away from heat or open flame.

DISPOSAL: Do not re-use empty container. Wrap container and put in trash collection.
