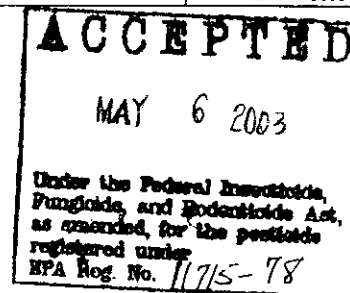

FIRST AID	
IF SWALLOWED:	<ul style="list-style-type: none"> Call poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

IF INHALED:	<ul style="list-style-type: none"> Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.
IF ON SKIN OR CLOTHING:	<ul style="list-style-type: none"> Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.
IF IN EYES:	<ul style="list-style-type: none"> Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

SHAKE WELL BEFORE USING

TO KILL FLEAS

Hold bottle upright and point nozzle opening in desired direction of spray. Pump the cap up and down with forefinger to create spray. Apply at the rate of one second per pound of body weight.

Spray the animal from a distance of 3-12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure that the animal's entire body is covered, including the legs and under the body. While spraying, fluff the hair so the spray will penetrate to the skin. Make sure spray wets thoroughly. Do not spray into eyes, face or genitals. Repeat weekly, if needed.

Do Not Use On Cats Under 12 Weeks. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals, or animals on medication.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry area away from heat or open flame.

DISPOSAL: **If empty:** Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
