## Precautionary Statements Hazards to Humans and Domestic Animals

### CAUTION

### GENERAL CLASSIFICATION

### STORAGE AND DISPOSAL

**Storage:** Store in a cool area away from heat or open flame.

**Disposal:** Do not reuse empty container. Wrap container and put in trash collection.

### SHAKE BEFORE USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS.

**To Protect Woolen Articles:** Brush woolen articles clean, air and remove persistent spots and stains by dry cleaning. Holding dispenser at least two feet from garment, spray thoroughly. Treated articles should be put in darkened closet or other darkened storage area. For best protection, clean and spray insides of closets or storage units for 30-40 seconds before putting treated articles away. This will kill the larvae and adults of carpet beetles and clothes moths. Treatment should be repeated every six months or as needed. Dry clean treated clothes before wearing.
