


STATEMENT OF PRACTICAL TREATMENT

PHYSICAL HAZARDS

STORAGE AND DISPOSAL


Storage: Store in a cool area away from heat or open flame.

Disposal: Do not reuse empty container. Wrap container and put in trash collection.

Remove protective cap, and spray from distance of 8-12 inches from surface to be protected. Slightly moisten surface -- saturation is not necessary. Use slow sweeping motion.

FOR EXPOSED SKIN AREAS, to repel flies, gnats and mosquitoes: Use as directed above. AVOID CONTACT WITH EYES OR MOUTH. For treating face, spray in palm of hand, rub palms together and rub on face.

FOR CLOTHING, to repel ticks, fleas and chiggers: (See CAUTION) - Make liberal application along all openings of the clothing, such as inside the neck band, the fly and cuffs of trousers, tops of socks, eyelets of shoes and areas of clothing which may contact the ground, weeds or other growth.
