FOR CONTROL OF WASPS & HORNETS

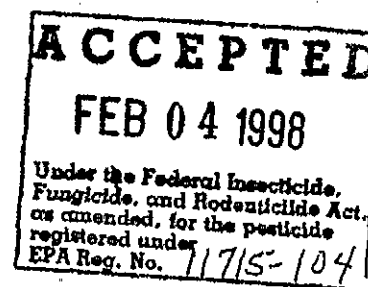
It is preferable to apply this product after dark when all the insects have returned to the nest. Aim valve opening at the nest and depress button, continuing to spray until the nest is soaked with the spray. Repeat as necessary.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry area away from heat or open flame.

DISPOSAL: Replace cap and discard container in trash. Do not puncture or incinerate.
