

#### DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

DO NOT use more than one fogger per room. DO NOT use in small, enclosed spaces such as closets, cabinets or under counters or tables. Do not use in a room 5 ft x 5 ft. or smaller, instead, allow fog to enter from other rooms. Turn of ALL ignition sources such as pilot lights (shut off gas valves), other open flames or running electrical applicances that cycle off and on (i.e., refrigerators, thermostats, etc) Call your gas utility or management company if you need assistance with your pilot lights.

PREPARATION: Cover emposed food, dishes, and food handling equipment. Open cabinets and doors to areas to be treated. Shut off fans and air conditioners. Put out all flames except pilot light. Close doors and windows. Point valve opening away from face and cyes when releasing. Use one unit for each 6,000 cubic feet of unobstructed area. Use additional units for remote rooms or where free flow of mist is not assured. Do not remain in the area during treatment and ventilate thoroughly

before re-entry.

TO START FOGGING: Place fogger on table, chair or stand, at least six feet from pilot light. Place several thicknesses of newspapers under canister to prevent marring of surface. Hold can at arm's length with top of can pointing away from face and eyes. Push down on finger pad until it locks. This will start fogging action. Set canister in upright position on table, etc. and leave building at once.
