If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

CAUTION**

Harmful if swallowed. Avoid inhalation of vapors. Avoid contact with skin, eyes, or clothing. Wash contaminated skin promptly with soap and warm water. For eyes, flush with plenty of water. If on skin—Remove contaminated clothing and wash affected areas with soap and water.

If in eyes—Flush eyes with plenty of water. Get medical attention, if irritation persists.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Atropine by injection is antidotal only if symptoms of cholinesterase inhibition are present.

PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Do not use near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130 F may cause bursting.
