Thoroughly spray cracks, crevices, along and behind baseboards and door frames. Allow carpet furniture legs to prevent staining. After replacing furniture, spray balance of carpeting as above.

Leave treated areas and do not return for at least one hour. Do not allow children or pets to walk on treated surfaces until they are completely dry.

FLEAS, BROWN DOG TICKS, MITES & LICE IN DOG HOUSES AND KENNELS: Remove and destroy pet bedding. Spray interior of dog house, sills and ledges and outside runways.

ROACHES, WATERBUGS, CRICKETS, AND CENTIPEDES: Thoroughly spray cracks, crevices, baseboards and around garbage containers and other places where insects habitate.

SILVERFISH AND FIREBRATS: Apply to cracks, baseboards, behind shelving, book cases and other storage areas.
