

To Kill Fleas, Lice and Ticks: Dilute 4 ounces of Concentrate with 1 gallon of water. Dip animal into solution, making sure hair is thoroughly wet to the skin. The area around the ears should be sponged thoroughly. Avoid contact of material with eyes and mouth of animal. Repeat as necessary for control.
