2. The type for the letters for the signal word **WARNING** should be larger than the type for **KEEP OUT OF THE REACH OF CHILDREN**. See the enclosed copy of page 3-6 from the Label Review Manual (1996).
3. Please revise the following **PRECAUTIONARY STATEMENTS** sentence to read: "Wash thoroughly with soap and water after handling and before eating, drinking, or using tobacco."
4. A stamped copy of the accepted label for **MAGIC GUARD** (EPA Reg. No. 11715-158) is enclosed for your record.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

(Keep diluted spray away from light).

Do not use on puppies less than 12 weeks old.

Do not use on cats.

TO KILL FLEAS, TICKS, AND LICE ON DOGS:

ON DOGS: DO NOT USE MORE THAN 1 FLUID OUNCE (2 Tbsp.) (30 ml) PER GALLON (3.79 L) ON PUPPIES:

Avoid contact with eyes, nose or mouth of animal.

For fleas and lice, dilute MAGIC GUARD insecticide at the rate of 1 fluid ounce (2 Tbsp.) (30 ml) per gallon (3.79 L) of water. [For puppies, use 1/2 fluid ounce (1 Tbsp.) (15 ml) per 1 gallon (3.79 L) of water] Apply directly to animal as a spray, sponge-on or a wash. Treat until animal's skin is wet. Do not rinse.

For ticks, dilute MAGIC GUARD insecticide at the rate of 2 fluid ounces (4 Tbsp.) (60 ml) per 1 gallon (3.79 L) of water. [For puppies, use 1 fluid ounce (2 Tbsp.) (30 ml) per 1 gallon (3.79 L) of water]. Apply directly to animal as a spray, sponge-on or a wash. Treat until animal's skin is wet. Do not rinse.

Do not reapply product for 7 to 10 days.
