Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Repeat as necessary.

Fleas and Brown Dog Ticks: Remove all bedding. Thoroughly spray cracks, crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings where pets normally lie down. Do not spray on pets. Allow the sprayed areas to dry thoroughly. Treat your pet with a registered flea and tick product to control the source of your infestation. Replace bedding before permitting use by animals. For dog kennels, apply to outside runways, window sills and ledges.
