NOT FOR USE ON CATS

FIRST AID

IF SWALLOWED:

- Call poison control center or doctor immediately for treatment advice.

- Do not give anything by mouth to an unconscious person.

IF INHALED:

- Take off contaminated clothing.
- Rinse skin immediately with plenty of water for 15-20 minutes.
- Call a poison control center or doctor for treatment advice.

HOLD CONTAINER UPRIGHT SHAKE WELL BEFORE USING

This product will kill fleas up to 14 days and ticks up to 7 days on dogs. **Do not use this product on cats.**

Spray the animal from a distance of 8-12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure that the animal's entire body is covered including the legs and under the body. Fluff the hair as you spray so the spray will penetrate to the skin. The spray should wet the ticks thoroughly. Do not spray in face, eyes or on genitalia. Repeat weekly, if needed.
