Dear Mr. Washburn:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. Revise front of the label – replace “Inert Ingredients” with the phrase “Other Ingredients”.
2. Delete all “Repeat as necessary” and “Repeat as needed” statements or indicate the repeat interval which should be based upon the residual effectiveness of the product.
3. The product was conditionally registered (03/26/90) with the provision that the following comments were complied with and submitted. We have not received a response.
  - a. Add to the Use Directions - “Do not use this product in or on electrical equipment due to the possibility of shock hazard.”
  - b. Resubmit the flashpoint of the product with propellant for the Confidential Statement of Formula and the flashpoint/flame extension of the product for the data matrix. The flashpoint reported exceeds the one expected for the product.
4. Under Precautionary Statements delete, “In case of contact immediately flush skin and eyes with plenty of water” and “If poisoning occurs get prompt medical aid”. This is already addressed under First Aid.

waterbugs, silverfish, ticks, fleas, and other insects listed below. Apply this product only as a coarse spray or crack and crevice treatment to localized areas, where pests are found or may occur. Spray surfaces until wet. Repeat as needed.

#### FOR SPOT TREATMENT

**To Kill Ants, Cockroaches, Crickets, Silverfish, Spiders, Sowbugs, and Carpet Beetles:** Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices in walls, along baseboards and door and window frames, behind and beneath sinks, stoves, refrigerators, and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Repeat as necessary.

**To Kill Brown Dog Ticks and Fleas:** Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present.
