- e. Revise HAZARDS TO HUMANS AND DOMESTIC ANIMALS as follows:

Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with eyes, skin or clothing. Avoid breathing spray mist. Wash with soap and water after handling. Remove birds and cover fish aquariums before spraying.

Add to the ANIMALS section:

Do not use this or any other pesticide on sick, old, debilitated animals.

- f. Since this product is limited to use on animals or in milk rooms, delete the paragraph beginning "Do not use in the edible product areas ....etc."
- g. Delete "Multi-Purpose" from the products name since this product is for use only in milk rooms and on animals.
- h. Under animal quarters and milk room direction add, "Remove animals prior to treatment."
- i. Add the following precaution to the Precautionary Statements:

Wear full-faced gas mask with canister type recommended for general insecticide protection when applying indoors as a space spray.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

Avoid spraying in eyes. Avoid breathing spray mist. Avoid contact with skin. Wash hands thoroughly after use. Vacate room after treatment and ventilate before reoccupying. Avoid contamination of feed and foodstuffs. Cover or remove fishbowls. This product is not for use on humans.

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not use in the edible product areas of food/feed processing plants, restaurants, or other areas where food/feed is commercially prepared or served. Do not use in serving areas while food is exposed.

### SHAKE WELL BEFORE USING

Remove protective cap, hold container upright and spray from a distance of 12 to 15 inches.

**In animal quarters and milk rooms:** For rapid control of House Flies, Mosquitoes, Gnats, Wasps, Hornets, Bees and Small Flying Moths, close windows and doors and spray at the rate of 2 seconds per 1000 cubic feet of space. For best results, keep area closed for 10 minutes after spraying. Do not remain in treated area and ventilate after treatment is completed.

**To treat livestock:** To protect beef cattle, dairy cattle, goats, sheep, hogs and horses from attacks of Stable Flies, Horse Flies, Deer Flies, Face Flies, House Flies, Horn Flies, Mosquitoes, and Gnats: Spray about 3 seconds on each side being careful to spray back, withers and forelegs thoroughly. To protect from face flies, spray the face and head, but do not spray into eyes. Repeat treatment when flies are troublesome.

**For Swine:** Do not ship animals for slaughter within 5 days of last treatment.

### For use on Dogs and on Premises to Control Fleas and Ticks:

**Fleas and Ticks:(Adults and Larvae):** Remove and thoroughly clean or destroy pet bedding. Spray pet sleeping quarters, bed, entire floor and floor covering with special attention to cracks and crevices around baseboards, and window and door frames. Infested upholstered furniture may also be treated with this product. A test application should be made to upholstery or drapery fabrics in an inconspicuous place before use.

**To control Fleas, Ticks and Lice on Dogs.** Starting at the tail, stroke against the lay of the hair, spraying the parted fur in short bursts, directly behind the hand to insure penetrating the coat. Dampen the fur up to the head. Repeat application weekly if necessary to control investigations. NOTE: Not recommended for use on puppies less than four weeks old.

### STORAGE AND DISPOSAL

**Storage:** Store in a cool, dry area. Do not transport or store below 32°.

**Disposal:** Wrap container in several layers of newspaper and dispose of in trash. Do not incinerate or puncture.
