

For best results, lawn should be mowed a day or two before spraying. Spray using a slow, even sweeping motion, being sure to cover the entire lawn surface where the pets will normally frequent. Spray under ornamentals and trees, but avoid soaking young or flowering plants. Repeat treatments may be necessary at 7 to 14 day intervals. Kills on contact the Ixodes dammini tick (deer tick), which transmits lyme disease. Also kills foraging fire ants upon direct contact.
