Dear Ms. Butler:

The amendment referred to above, submitted in connection with registration under section 3 (c)(5) of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable, subject to the comments listed below.

- 1. Under the "Precautionary Statements" section, move the following statements to your "Directions for Use" section: "Avoid contamination of ...classrooms are in use." Revise the "Wash with...use" statement to read "Wash thoroughly with soap and water after handling." Delete the statements "In case of...water" and "Obtain medical...persists."
- 2. Revise your "Spray surfaces until wet" statement to read "Spray surfaces until wet but not to the point of runoff."
- 3. Either delete the phrases "Repeat as necessary", "Repeat as needed" and "Repeat treatment as necessary" or indicate a time period based on the residual efficacy of your product.
- 4. Add the following statement to the end of the tick and flea section: "Also, treat your yard with a product registered for yard application."
- 5. Add the following statements to the "Directions for Use" section after the "Do not apply in classrooms when in use" statement: "Do not apply this product in occupied patient rooms or in any rooms/areas while occupied by patients, the elderly or infirm. Do not apply to institutions (including libraries, sports facilities, etc.,) in the immediate area when occupants are present."

6. Add the following precaution to the paragraph under Flies and Mosquitoes "Remove all exposed food and cooking utensils. Cover all food handling surfaces or wash thoroughly after treatment and before use. Do not use on edible crops."

# PRECAUTIONARY STATEMENTS

# HAZARDS TO HUMANS AND DOMESTIC ANIMALS

# **CAUTION**

Harmful if swallowed, absorbed through the skin. Do not breathe vapors or spray mist. Avoid contact with skin or eyes. In case of contact flush with plenty of water. Wash with soap and warm water after use. Obtain medical attention if irritation persists. Avoid contamination of food or foodstuffs.

# **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

### SHAKE WELL BEFORE USE

GENERAL: Use this spray as a spot or crack and crevice treatment to control cockroaches, fleas, silverfish, ticks, waterbugs, and other insects listed below. Apply this product only as a coarse spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surfaces until wet. Repeat as needed.

Do not use as a space spray.

Not for use in USDA Meat and Poultry Plants.

# FOR SPOT TREATMENT

To Kill Ants, Cockroaches, Crickets, Silverfish Spiders, Sowbugs, and Carpet Beetles: Spray areas where these insects are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets; and around garbage cans, plumbing, and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows, and wherever else these pests may find entrance. Repeat as necessary.

To Kill Brown Dog Ticks and Fleas: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. DO NOT SPRAY PETS WITH THIS PRODUCT.

# FOR CRACK AND CREVICES

To Kill Ants, Cockroaches, Crickets, Silverfish, Sowbugs, Spiders, Brown Dog Ticks, Fleas, and

Carpet Beetles: Apply spray in small amounts directly into cracks and crevices. Spray should be directed into points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where these insects hide.

Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food handling surfaces.

Flies and Mosquitoes: Use only outdoors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios, and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when necessary.

# STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Keep container closed.

**DISPOSAL:** Do Not Puncture or Incinerate!

If empty: Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.
