REAPPLICATION DIRECTIONS

Do not reapply product for 7 days.

STORAGE AND DISPOSAL

Storage: Store on only in a cool, dry place inaccessible to children and pets.

Disposal: When empty, replace cap, securely wrap in newspaper, and discard in trash. Do not incinerate or puncture.
