Delete the phrase "...eliminate fleas from your pet's life..." and replace it with "...kills fleas...". The former phrase suggests a permanent remedy, and as such, is misleading to the user.

Spray animal until thoroughly wet but avoid run off. Do not spray around eyes, on face or on genital area to avoid irritation. Use spray in well ventilated areas. Do not use more often that once every two days on animal. If pet bedding is heavily flea infested, remove old bedding and replace with fresh; spray may be used to treat bedding.
