This action is taken under the authority of section 4(g)(2)(C) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. Reregistration under this section does not eliminate the need for continual reassessment of pesticides. EPA may require submission of data at any time to maintain the registration of your product.

The labeling referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable provided that you make the following changes and submit one (1) copy to us before you ship product:

1. Add the First Aid section at the end of the Precautionary Statements section as follows:

"First Aid

If on Skin: Wash with plenty of scap and water. Get medical attention if irritation persists. If in Eyes: Flush eyes with plenty of water. Call a physician if irritation persists."

- 2. Since it is an outdoor-use product only, delete "For both indoor and outdoor situations" from the DIRECTIONS FOR USE section to reduce ambiguity.
- 3. In the Directions for Use section, delete 'OUTDOOR USE: Keeps pets away from trees, shrubs, garbage cans/bags, and other 'forbidden areas.' ' because this is already stated in other areas of the label so that the label is succinct and clear to the reader.
- 4. In Application Directions, it is suggested that the sentences "Do not apply to foliage or shrubs or to ornamental, soft-bodied plants. Do not apply to food or feed crops." be deleted because it is already stated in the Use Restrictions section so that the label is more succinct and effective.
- 5. On the front panel change "up to 10 days" to "up to 24 hours".

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the labeling is enclosed for your records.
