Dear Ms. Speer:

The amendment referred to above, submitted in connection with registration under section 3 (c)(5) of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable, subject to the comments listed below.

- 1. Delete the phrase "No Unpleasant odor" from your label. This is a subjective statement that is based on the sensitivity of the individual user.
- 2. Because your product contains petroleum distillate, add the following statements to your FIRST AID section:
 - "IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Do not give any liquid to the person. Do not induce vomiting unless told to do so by a poison control center or a doctor. Do not give anything by mouth to an unconscious person.
- 3. Revise your Precautionary Statements to read: "Harmful if swallowed, absorbed through the skin, or inhaled. Causes moderate eye irritation. Avoid breathing vapor or spray mist. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling."
- 4. Either delete the phrase "or when necessary" or indicate a time period based upon the residual efficacy of your product.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

IMPORTANT! TO AVOID FLAMMABILITY HAZARD, USE CAN AS FOLLOWS:

DO NOT use more than one fogger per room. DO NOT use in small, enclosed spaces such as closets, cabinets or under counters or tables. Do not use in a room 5 ft. x 5 ft. or smaller; instead, allow fog to enter from other rooms. Turn off ALL ignition sources such as pilot lights (shut off gas valve), other open flames or running electrical appliances that cycle off and on (i.e., refrigerators, thermostats, etc.). Call your gas utility or management company if you need assistance.

One 6 ounce aerosol can treats up to 6,000 cubic feet of unobstructed area (a room 30' x 25' with an 8 foot ceiling).

For Fleas and Ticks, use one 6 ounce can for every 6,000 cubic feet of room space.

Not for use in Federally Inspected Meat and Poultry Plants.

Do not use in food/feed areas of food/feed handling establishments, restaurants or other areas where food/feed is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods are served such as dining rooms, but excluding areas where foods may be prepared or held. In the home all food processing surfaces and utensits should be covered during treatment or thoroughly washed before use.

For use in non-food areas such as garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

HOW TO USE:

Step 1: PREPARATION

Open cupboards, cabinets, trunks, and doors to area to be treated to allow maximum kill in all areas where insects can hide and breed. Close outside doors and windows and shut off fans and air conditioning to maximize killing power of fog. Remove pets, birds, and tightly cover or remove fish bowls and aquariums before spraying. Cover waxed wood floors and waxed furniture in the immediate area surrounding the fogger (newspapers may be used). Remove or cover exposed foods, dishes, utensils or food handling equipment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using.

Step 2: ACTIVATION

SHAKE WELL JUST BEFORE USING.

*Place a section of newspaper on floor in center of room to be treated.

NOTE: Do not place fogger on water-stainable surface. Tilt can opening away from face and depress tab firmly with thumb until it clicks in locked position. Aiming spray away from face, set fogger on newspaper, leave room and close

door. After activation, leave room or house at once. Keep area closed for 2 hours (30 minutes for flying insects) before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Do not store near heat or open flame. Store in cool dry area away from children.

DISPOSAL: Do not puncture or incinerate! If **empty:** Place in trash or offer for recycling if available. If **partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.
