INDOOR USE:

Speer Permethrin Dusting Powder is intended for applications with hand or power duster (Actisol® or



similar equipment), or by other suitable means, to hiding and runway areas and other places where insects are found. To apply insecticide directly into cracks and crevices, use a bulbous duster or other suitable equipment. Apply lightly and uniformly to infested areas.

COCKROACHES (including adult and immature stages of both non-resistant and organophosphate and carbamate resistant strains), ANTS, CRICKETS, SILVERFISH AND FIREBRATS: Apply thoroughly at a rate of 3 to 6 ounces per 100 square feet to all areas where these pests crawl and hide, especially in cracks and crevices and hidden surfaces around sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and stoves and in attics and crawl spaces. For Ants. sprinkle freely around ant trails, doors and windows and other places where ants enter premises around nests hidden under steps, brickwork, concrete, etc. Break apart accessible nests and scatter powder freely on and around debris. Repeat as necessary.

BROWN DOG TICKS AND FLEAS IN BUILDINGS: Apply dust at a rate of 3 to 6 ounces per 100 square feet to infested areas such as pet beds and resting quarters, nearby cracks and crevices, under the edges of rugs and floor coverings, between and under cushions of upholstered furniture and other areas where these pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment of pet areas.

SPIDERS: Apply at a rate of 3 to 6 ounces per 100 square feet along and behind baseboards, to window and door frames, corners, pipes, storage localities, attics, crawl spaces and other areas over which these pests may crawl.

SOWBUGS, PILLBUGS, GROUND BEETLES, EARWIGS, MILLIPEDES, CENTIPEDES AND SCORPIONS: Apply at a rate of 3 to 6 ounces per 100 square feet around doors and windows and other places where these pests may enter premises. Treat baseboards, storage areas and other locations where these pests are found.

WASPS AND BEES: It is generally advisable to treat wasp and bee nests in the evening when the insects are

less active and have returned to the nest. Wear protective clothing if deemed necessary to avoid stings. Using hand or power duster or other suitable means, with extension tubes if necessary, thoroughly dust nest and entrance and surrounding areas where insects light. Nests in wall voids can be located by listening with your ear against the wall. Drill a hole in the area, blow dust in, and reseal. For ground wasps, dust entrance and surrounding areas. For best results.

check nests carefully one or two days after treatment to ensure complete kill, then remove and destroy nest to prevent emergence of newly-hatched insects. If removal is not feasible, retreat the nest, if necessary. Do not use this product to treat overhead nests.

PANTRY PESTS - GRAIN BEETLES (RUSTY, MERCHANT AND SAW-TOOTHED), FLOUR BEETLES, (RED AND CONFUSED), DRUGSTORE BEETLES, RICE WEEVILS, LESSER GRAIN BORERS, SPIDER BEETLES AND TOBACCO MOTHS: Treat exposed stages. WEBBING CLOTHES MOTHS: Use this product as a crack and crevice treatment in closets and other storage areas where these pests are found. This is an adjunct treatment and will not control moth larvae already on the clothes. Do not apply to clothing.
