


#### DIRECTIONS FOR USE

#### GENERAL INFORMATION

On garden soils to be planted later, thoroughly prepare the soil, break up all clods, remove all weeds and grasses and smooth the surface. Apply the recommended rate of EZE Garden Weed Preventer over the surface of the area to be treated using a granular applicator or seeder. Immediately after application incorporate the herbicide into the soil to a depth of 2 to 3 inches using a roto-tiller or rake. Incorporation should be done in two directions, one at a right angle to the other, to insure more uniform distribution of the herbicide. Shallow cultivation during the season will not reduce weed control with EZE Garden Weed Preventer. On established plantings, remove all existing grasses and weeds, then apply the recommended rate uniformly to the soil surface. Immediately work into the soil surface with a roto-tiller or rake being careful not to disturb the roots of the established plants.

WILL NOT CONTROL certain resistant weeds such as Cocklebur, Velvetleaf, Jimsonweed, Ragweed, Venice Mallow, Nutgrass and established Bermuda and Johnsongrass.

#### GENERAL PRECAUTIONS AND RESTRICTIONS

This product is not recommended for use on muck soils. Do not apply to any vegetable crop not listed on the label. Do not apply to Ajuga, Myrtle, Pachysandra and other ornamental groundcovers as injury may result. Use only at the rate recommended; overtreatment may cause injury. Applications made according to directions and under normal growing conditions will not harm treated plants. Seedling disease, cold weather in combinations with deep planting and excessive moisture, high salt concentration, and drought may weaken crop seedlings and increase the possibility of damage from this product. Under these conditions, delaying crop development may result.

Do not allow people or pets to enter the treated area until dusts have settled. If watering-in is required after the application, do not enter or allow others to enter the treated areas (except those involved in the watering) until the watering-in is complete and the surface is dry.

#### RATES OF APPLICATION FOR VEGETABLES

RECOMMENDED FOR USE ON: Drybeans, Southern Peas (cowpeas, field peas, blackeyed peas), Snap Beans, Lima Beans, Okra and transplants of Tomatoes, Peppers, Broccoli, Brussels Sprouts, Cabbage, Cauliflower: Apply from 6 weeks before planting up to day of planting. Except on Snap Beans and Lima Beans apply at the following rates: Use 1 pound to 1500 square feet on sandy and sandy loam (light) soils. Use 1 pound to 1000 square feet on loam (medium) soils. Use 1 pound to 750 square feet on silt and clay (heavy) soils. On sandy soils containing 2-5 percent organic matter apply 1 pound per 750 square feet. On Snap Beans and Lima Beans apply 1 pound to 1500 square feet on sandy, sandy loam or loam soils and 1 pound to 1000 square feet on silt and clay soils.

FOR ORNAMENTAL SHRUBS, TREES AND FLOWERS?

RECOMMENDED FOR USE ON: Established Shrubs and Trees, and these Flowers: Ageratum, Aster, Balsam, Calendula, California Poppy, Calliopsis, Carnation, Çoşmos, Daffodils, Dahlia, Forget-Me-Not, Four O'Clocks, Gaillardia, Gladiolus, Hollyhack,

Lobleia, Marigold, Morning Glory, Nasturtium, Periwinkle, Petunia, Portulaca, Shasta Daisy, Snapdragon, Stocks, Sunflower, Sweet Alyssum, Sweet Pea, Tulips, Zinnia. Apply at the rate of 1 pound to 750 to 1000 square feet in the spring around shrubbery and trees and in flower beds after plants have become established.
