- b. In the ingredients statement, align all the decimal points. Also, two of the ingredients have asterisks after their name but there are no footnotes to which these asterisks refer.
- c. Based on the toxicity profile for this product you may delete the If Inhaled, If in Eyes and If Swallowed first aid statements. Likewise revise the Hazards to Humans and Domestic Animals section to read, "Repeated exposure to Etofenprox can cause skin irritation." Avoid contact with skin or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or using tobacco.
- d. Move the statements beginning "Do not allow children or pets...etc. and ending... Exposed food should be covered or removed." to the Directions for Use section.
- e. On the front panel add: "For Use Indoors at Residential Sites Only."
- f. Under Directions for Use replace "eliminate" with "control".

- g. On front panel delete "photo stable". No information or data was submitted to support such a claim.
- 6. Submit three (3) copies of your final printed labeling before you release the product for shipment.

## DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling .  
**READ THE ENTIRE LABEL PRIOR TO USE. USE STRICTLY IN ACCORDANCE WITH ALL LABEL PRECAUTIONS AND DIRECTIONS.**

Remove all exposed food and cooking utensils. Cover all food handling surfaces and wash thoroughly after treatment and before use. Do not use on edible crops.

## SHAKE WELL BEFORE USE

Remove pets, birds and cover fish aquariums before spraying. Do not allow children or pets to contact surface until spray has dried.

**Indoors:** Thoroughly vacuum all carpeting, upholstered furniture, along baseboards, under furniture and in closets. Seal vacuum bag and dispose of in trash outdoors.

Spray Etofenprox IGR Home and Carpet Spray I<sup>2</sup> from 2 feet to 3 feet away from surface being treated. Apply with a smooth back-and-forth motion to carpets, drapes, rugs, and upholstered furniture. Avoid wetting or saturating of carpets or furniture. A fine mist spray that is evenly applied will do the job properly. Do not spray wood furniture, floors or trim as water spotting may occur. Repeat treatment every 14 days to eliminate adult fleas and ticks.

**Apply directly to exposed insects - roaches, ants, spiders, crickets, waterbugs, silverfish, sowbugs, and carpet beetles:** Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices, along baseboards and door sills and frames, behind sinks, stoves, refrigerators, and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests and points of entry. Repeat treatment every 14 days.

**On Pet Bedding:** Treat pet bedding and resting places. Apply a uniform application of Etofenprox IGR Home and Carpet Spray I<sup>2</sup> to nearby cracks and crevices, along and behind baseboards, window and door sills, and localized areas of floors where fleas or ticks may be present as these are primary hiding places for fleas. Pet bedding does not need to be removed after treatment.

**Repeat treatments to infested areas as necessary at intervals of 14 days or greater. Do not make more than 6 applications per site per year.**

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**STORAGE:** Do not store near heat or open flame. Store in a cool, dry area away from children.

**DISPOSAL:** Do Not Puncture or Incinerate!
