

Subsequent additions of 13 fluid ounces of _____ Algae-X _____ per 10,000 gallons of water 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, or decorative fountains having algae should require an initial dose of 8 to 12 fluid ounces of _____ per 1000 gallons of water. For treatment of a freshly cleaned hot tub, or decorative fountain, add initially 4 fluid ounces of _____ Algae-X _____ per 1,000 gallons of water.
