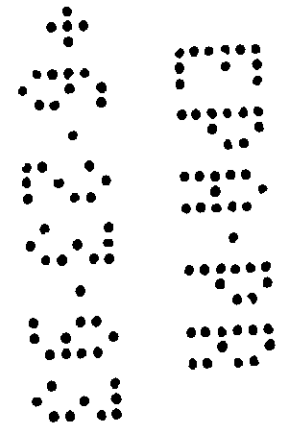

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SHAKE BEFORE USE • HOLD CONTAINER UPRIGHT • APPLY IN SHORT BURSTS

FOR SPACE SPRAY

To Kill Flies, Gnats, Mosquitoes, Small Flying Moths and Wasps: Close all doors and windows and direct spray upward into center of room with a slow sweeping motion. Spray 5-10 seconds for average room. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before reentry. Sweep up and discard fallen insects. Before spraying, cover exposed food and utensils.

FOR SPOT TREATMENT

To Kill Ants, Cockroaches and Crickets: Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators, food storage areas and wherever these pests are suspected of hiding. To kill ants, treat doors, around window frames, ant trails and other areas of entry. Repeat as necessary.

To Kill Exposed Forms of Confused Flour Beetles, Rice Weevils and Saw-toothed Grain Beetles: Find and discard infested package goods. Remove all other items from pantry. Spray the shelves to kill any of the listed insects present. After shelves have dried, place clean paper on the shelves and return uninfested packages. Repeat as necessary.

To Kill Centipedes, Firebrats, Silverfish, Sowbugs and Spiders: Contact as many insects as possible with the spray. Also thoroughly spray all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, crevices, hidden surfaces under sinks, and behind stoves and refrigerators.

To Kill Brown Dog Ticks and Fleas: Remove and destroy pet's old bedding. Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and local areas of floors. Repeat as necessary. Old bedding should be removed and replaced with clean, fresh bedding after treatment. **DO NOT SPRAY ANIMALS WITH THIS PRODUCT.** Treat pets with a flea and tick control product, registered for use on pets, before allowing them to enter treated area.

FOR CRACK AND CREVICE

To Kill Ants, Brown Dog Ticks, Carpet Beetles, Cockroaches, Crickets, Fleas, Silverfish, Sowbugs and Spiders: Apply spray in small amounts directly into cracks and crevices. Equipment capable of delivering a pin stream should be used in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, and equipment legs and bases where the above listed insects hide. Avoid contamination of food or food processing surfaces.

Storage: Store in a cool, dry place (preferably locked), inaccessible to children and pets and away from heat or open flame. **Disposal:** Replace cap, wrap in newspaper and discard in trash. Do not incinerate or puncture.

PRECAUTIONARY STATEMENTS

Hazards to Humans & Domestic Animals

CAUTION: Harmful if swallowed or absorbed through skin. Do not breathe vapors or spray mist. Avoid contact with skin or eyes. Wash with soap and water after use. Avoid contamination of food or feedstuffs. Do not use in commercial food processing, preparation, food storage or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Cover or remove exposed food. Remove pets, birds and cover aquariums before spraying.

Statement of Practical Treatment

If Swallowed: Immediately contact a physician or poison control center. **If Inhaled:** Remove person to fresh air and apply artificial respiration if indicated. Contact a physician if warranted. **If In Eyes:** Flush with plenty of water. Get medical attention if irritation persists. **If On Skin or Clothing:** Wash with soap and warm water. Get medical attention if irritation persists. Wash clothing prior to reuse.

Physical or Chemical Hazards

Contents under pressure. Keep away from heat, sparks and open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.
