### GENERAL INFORMATION

This product is a powdered insecticide for use on stored grains: Med. Corr. Das. Rye, Barley. Grain Sorghom, Rice, Fleid and Garden Seeds. When used on stored grains protection is provided against Confused Flour Beetle, Rice Weevil, Granary Weevil, Saw-Toothed Grain Beetle, Flat Grain Beetle, Red Flour Beetle, Russy Lifain Beetle, Lesser Grain Borer, and Inglan Med. Moth.

Use of this product as directed will be within the tolerance of 8 parts per million for malathion. Treated grain is not subject to downgrading and can be milled into flour or feed using normal production methods.

### DIRECTIONS

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

#### FOR USE ON STORED GRAINS:

Apply this product to the grain at the rate of 30 lbs per 1000 bu, as the grain is being loaded or turned into final storage.

Field and garden seeds can be protected against grain pests with a oosage of 30 lbs. of this product per 1000 but of seed.

To protect stored grains from attack by Indian Meal Moth, apply this product to the surface of clean or uninfested grain at the rate of 15 lbs. per 1000 sq. feet of grain surface area. Apply the dust evenly over the surface of the grain. Apply immediately after grain is loaded into storage and repeat if necessary.

### **HOW TO APPLY**

Apply this produc, when grain is in the truck or wagon prior to binning. To determine the amount in the truck or wagon, multiply the length by width by depth (all ir feet) and multiply this total by 0.8 to get the number o bushels. Measure out the correct amount of this product (30 lbs. per 1000 bu.) and spread evenly over the surface of the grain in the truck or wagon. Cut into the grain with a shovel. Coating will become mixed with grain as it is dumped from the truck or wagor into the hopper. Further mixing will occur when the grain is augered or blown into the bin. Mixing is completed as the coating and grain roll down the cone shaped pile in the bin.
