DIRECTIONS

For a new pool or for spa (1.5 flu. oz.) of sodium hypochlorite solution per gallon of water. This dosage is by weight.

FOR POOL MAINTENANCE

A) Adjust pool water pH to 7.2-7.6.
B) Add manually or by automatic chlorinator of 0.6 to 1.0 ppm. Chlorine hypochlorite solution of 1.0 ppm available chlorine maintain 0.6 to 1.0 ppm available chlorine and chlorine residual.

NOTE: This product does not increase dosage, as needed for chlorine.

STORAGE AND DISPOSAL: Store in original container, away from direct sunlight. In case of spill, do not wash into water. Rinse empty container into manufacturer or distributor's approved land fill. Do not discharge into water and do not ingest food or feed by animals.
