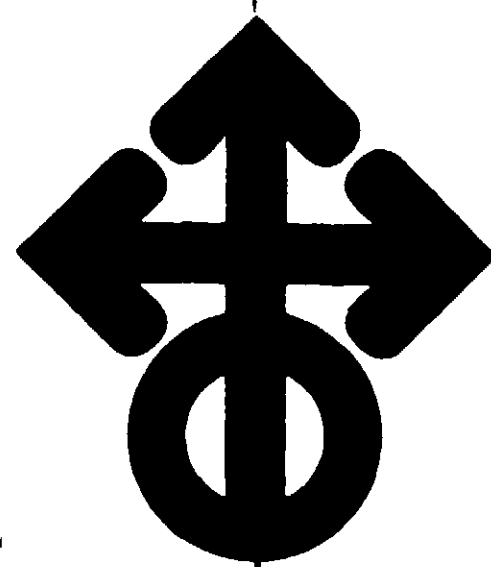

USE DIRECTIONS

Master Mix RABON[®] Livestock Dust is a ready-to-use insecticide dust which can be applied by hand or through the use of self-treating dust bags. There is no withholding period from last application to slaughter.

For Horn Flies and Face Flies on beef and dairy cattle, use Master Mix Rabon Livestock Dust as follows:

HAND DUSTING — Apply approximately 2 oz. of dust by shake can, rotary duster or by spoon to the upper portions of the back, neck and poll, and to the face as an aid in the control of face flies. Rub in lightly to carry the dust beneath the hair. Repeat as necessary.

SELF-TREATING DUST BAG — FORCED USE — Puncture the Master Mix Rabon Livestock paper sleeve and insert into the dusting bag. Hang in barn door exits or alleyways leading from animal buildings, salt or mineral blocks, or watering holes. Protect cloth or burlap bags from weather.

FREE CHOICE USE — Use the same dust bags as above but place in loafing sheds, holding pens, feedlots, near watering holes or other areas where cattle gather. The Free Choice use aids in the control of Lice.

PRECAUTIONS IN USING

Harmful if swallowed. Avoid breathing dust. Do not get in eyes, on skin, or on clothing. If the material gets into the eyes, wash with plenty of water for 15 minutes; if irritation persists, see a physician. Wash thoroughly with soap and water after handling and before eating or smoking. Avoid contamination of feed and foodstuffs. Keep away from heat and open flame. Do not apply in dwellings.

This product is toxic to fish. Keep out of lakes, streams or ponds. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.

Do not reuse empty container. Destroy it by perforating or crushing. Bury or discard in a safe place.
