For dishes, glassware, silverware, cooking utensils, wash with soap or synthetic detergent; rinse thoroughly and immerse in a sanitizing solution containing 1 ounce per 4 gallons of water. **No terminal Potable Water Rinse Required.**

**Food Processing Equipment**

For sanitization of previously cleaned food processing equipment and food utensils dilute 1 ounce per 4 gallons of water to provide 200 ppm of active quaternaries. At this level, **No Potable Water Rinse** is required.

**Dairies**

To sanitize dairy equipment such as tanks, lines, pails, and milk cans, first clean and rinse the equipment thoroughly. Then apply sanitizing solution containing 1 ounce per 4 gallons of water to provide 200 ppm of active quaternaries. At this level, **No Potable Water Rinse** is required. Consult local Health Board for additional information.

This product when used on environmental, inanimate, hard surfaces at 3 1/2 ounces per 5 gallons of water is effective against Influenza A<sub>2</sub>, Herpes Simplex, Adenovirus type 2, and Vaccinia Viruses.
