**USE DIRECTIONS:**

**Disinfection**

Use at 2 ounces per gallon. This product will be effective against *Pseudomonas aeruginosa* PRD-10 at this level. This has been substantiated by the AOAC Use Dilution Confirmation Test. At this level, the product is fungicidal against pathogenic fungi.

For best results, use **LEM-O-CHEM** with a cloth or mop and apply to walls, floors and other hard surfaces.

For heavy soil or organic matter, a pre-cleaning step is recommended.

**Sanitization**

If used for sanitization of previously cleaned food equipment or food contact items, limit the level of active quaternaries to 200 ppm (2.8 ounces per 5 gallons of water). **POTABLE WATER RINSE REQUIRED.**

This product when used on environmental, inanimate, hard surfaces at 2 ounces per gallon of water, is effective against Influenza A<sub>2</sub>, Herpes Simplex, Adenovirus type 2, and Vaccina viruses.
