### DIRECTIONS FOR USE GENERAL CLASSIFICATION

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

CHEMEX 3125 ALGAE-RID is used to control the growth of algae in swimming pools. For maximum effectiveness, pools containing heavy growth of algae should be cleaned prior to using CHEMEX 3125 ALGAE-RID.

For pools having just visible algae growth add an initial dose of 75 to 115 fluid ounces of CHEMEX 3125 ALGAE-RID per 10,000 gallons of water and remove settled algae debris by cleaning.

For treatment of a freshly cleaned and filled pool, add initially 41 to 75 fluid ounces of CHEMEX 3125 ALGAE-RID per 10,000 gallons of water.

To maintain pools free of visible algae growth, subsequent additions of 13.5 to 27 fluid ounces of CHEMEX 3125 ALGAE-RID per 10,000 gallons of water should be made every 5 to 7 days after the initial treatment.

CHEMEX 3125 ALGAE-RID is compatible with those chemicals normally used to treat pools and effective at both acid and alkaline pH. CHEMEX 3125 ALGAE-RID can be used in pools treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix CHEMEX 3125 ALGAE-RID with concentrated dry or liquid chlorine products.

**STORAGE & DISPOSAL:** Keep container closed when not in use. Do not contaminate water, food, or feed by storage, disposal, or cleaning of equipment. The container must be triple rinsed (or equivalent) and offered for recycling, reconditioning, or disposal in an approved landfill or buried in a safe place. Rinstate that cannot be used or reprocessed should be disposed of in a landfill approved for pesticides or buried in a safe place away from water supplies. Open dumping is prohibited.
