If you intend to use this product to be a source for sites not listed above, you need to add them to your label (e.g., terrestrial noncrop areas, pome fruits, stone fruits, etc.)

- 2. Consider changing "PESTICIDE STORAGE" to "STORAGE".
- 3. Place your "DIRECTIONS FOR USE" after your "PRECAUTIONARY STATEMENTS".
