PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

WARNING: May be fatal if swallowed, absorbed through skin or inhaled. Do not get in eyes or on clothing. Do not inhale powder when mixing baits. Wear dust respirator, eye goggles and rubber gloves. Wash arms and face with soap and water after mixing or handling and before eating or smoking. Repeated exposure to small amounts of this product can produce accumulative toxicity. Persons at risk should have prothrombin times checked periodically. **Exposure to Contrac during pregnancy should be avoided.**

STATEMENT OF PRACTICAL TREATMENT: If swallowed, drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Have patient lie down and keep warm. Do not induce vomiting or give anything by mouth to an unconscious person. Get medical attention. If on skin, wash with plenty of soap and water. If in eyes, flush with plenty of water. Get medical attention if irritation persists. If inhaled, move to fresh air.

NOTE TO PHYSICIAN: If swallowed, absorbed, or inhaled by humans, domestic animals or pets this material may reduce the clotting ability of the blood and cause bleeding. In such cases, treat as bishydroxycoumarin overdoses, giving vitamin K₁ orally and intramuscularly in mild cases and giving vitamin K₁ intravenously and blood transfusions in severe cases. Repeat as necessary based upon monitoring of prothrombin times.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and wildlife. Keep out of lakes, streams or ponds. Do not discharge to surface water or waste water treatment systems.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

NOTICE TO FORMULATORS: Formulators who use this product are responsible for providing data to support their own registrations.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Open burning and dumping is prohibited.
