**Purpose** Each submission revises your label according to our last letter.

Claims We have the following comments about two claims on your proposed label: 1) allweather and 2) sewers.

#### 1. All-Weather

In our January 2, 1997, letter, we noted problems with the use of weather-resistant claims for this and related products because Bell had not submitted data on weathered product. To retain such claims and use of the product in wet or damp areas (including sewers), you need to submit the supporting data or remove these types of claims. Without data, we could not re-register this product with such claims.

2. Sewers

If you wish a sewer claim for these products, let us know, and we will determine the requirements.

- LabelThe labeling submitted with the above letter, under the Federal Insecticide,<br/>Fungicide, and Rodenticide Act (FIFRA) is acceptable, provided you submit one (1)<br/>copy of final printed labeling to us, with the following changes, before you ship your<br/>product.
  - 1. Add "Do not use in sewers." to your "USE RESTRICTIONS", as it had appeared in your January 2, 1997, label approval.
  - 2. For non-homeowner sizes (1 lb), use the following format for your "Storage and Disposal" text:

#### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Storage: Store ...other chemical. Pesticide Disposal: Wastes ... disposal facility. Pesticide Container: Do not ... proper disposal.

3. We prefer that you structure your "USE RESTRICTIONS" as follows to clarify the relationship between this heading and its two subheadings:

**USE RESTRICTIONS:** For control ... Do not broadcast bait. Do not use in sewers.

**Urban Areas:** This product ... in alleys. **Non-Urban Areas:** This product ... buildings.

- 4. For EPA Reg. No. 12455-79, include revised labeling for your 4 oz and 8 oz package sizes.
- 5. After "For control of Norway rats, roof rats, and house mice." add this sentence:

Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food.

A copy of the stamped label is enclosed for your records.

**Existing** Stocks of existing labels may be used for eighteen (18) months.

#### **DIRECTIONS FOR USE**

**READ THIS LABEL**: Read this entire label and follow all use directions and use precautions.

**IMPORTANT**: Do not expose children, pets, or nontarget animals to rodenticides. To help to prevent accidents:

- 1. Store unused product out of reach of children and pets.
- 2. Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from bait stations when they are lifted, units must be secured or otherwise immobilized. SELECTION OF TREATMENT AREAS: Determine areas where rats or mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Protect bait from rain and snow. Remove as much alternative food as possible.

Each CONTRAC CAKE consists of a one-pound slab scored to be broken into four-4  $cz_{-}$  pieces.

**RATS**: Break and apply 1 to 4 pieces of CONTRAC CAKE (usually at intervals of 15 to 30 feet) per placement. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

MICE: Obtain 1 oz. bait pieces by breaking 4 oz. pieces of CONTRAC CAKE in half and breaking each half in half. Use one-1 oz. piece per bait placement. Space placements at 8 to 12 foot intervals. Two-1 oz. pieces may be needed at points of very

high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until signs of mouse activity cease.

**FOLLOW-UP**: Replace contaminated or spoiled bait immediately. Collect and dispose of all dead, exposed animals and leftover bait. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.
