

#### DIRECTIONS FOR USE:

#### USE RESTRICTIONS:

DO NOT USE THIS PRODUCT IN AREAS ACCESSIBLE TO CHILDREN, PETS, DOMESTIC ANIMALS, AND NONTARGET WILDLIFE. For control of house mice in and around homes, industrial, commercial, agricultural, and public buildings. Do not place in areas where there is possibility of contaminating food or surfaces that come in direct contact with food.

#### SELECTION OF TREATMENT AREAS:

Determine areas where mice will most likely find and consume the bait. Generally, these are along walls, by gnawed openings, beside burrows, or in corners and concealed places.

#### APPLICATION DIRECTIONS:

HOUSE MICE: Place bait station at intervals of 8 to 10 feet along walls or in corners where mice live or travel. When bait is consumed, replace with one CONTRAC BLOX (EPA Reg. No. 12455-34). Do not fill this station with any bait other than CONTRAC BLOX.

TO REFILL: (See illustrations below) 1. Fully insert 2-pronged key in holes on top of CONTRAC Mouse Bait Station. 2. Bend key away from station. 3. Gently lift up. 4. Place one CONTRAC BLOX in the triangular area next to the hinge. 5. Close lid until it snaps securely. Repeat steps for easy rebaiting.

To prevent reinfestation, eliminate food, water and harborage as much as possible. If reinfestation does occur, repeat treatment.

#### STORAGE AND DISPOSAL:

Do not contaminate water, food, or feed by storage or disposal.

**STORAGE:** Store only in original container in a cool, dry place inaccessible to children and pets.

**DISPOSAL:** Securely wrap original container and/or unused, spoiled, or fragmented bait in several layers of newspaper and discard in trash.

#### PRECAUTIONARY STATEMENTS:

Hazards to humans and domestic animals.

**CAUTION:** Keep away from humans, domestic animals and pets. If swallowed, this material may reduce the clotting ability of the blood and cause bleeding. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling. If swallowed, call a physician at once.
