Purpose The purpose of this submission is to revise your label in accordance with PR Notices 2001 and 2001-6 and to make other minor changes.

Label review The labeling submitted with the above letter, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) is acceptable, provided you submit one (1) copy of final printed labeling to us, with the following changes, before you ship your product.

1. Change "For Formulating Use Only" to "A Rodenticide Only for Formulation into Registered Products for Use In and Around Structures and Inside Transport Vehicles to Kill Norway Rats, Roof Rats, and House Mice."
2. Under "Note to Physician or Veterinarian", delete "as ... overdoses."

4. Change the text under "WARNING" to:

May be fatal if swallowed or inhaled. May be irritating if absorbed through the skin. Do not get on skin or on clothing. Do not breathe dust. When mixing baits, use dust/mist filtering respirator (MSHA/NIOSH approval number prefix TC-21C) and wear protective clothing, and rubber gloves. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

5. Change "PESTICIDE STORAGE" to "STORAGE".

Existing stocks	Stocks of existing labels may be used for eighteen (18) months.
Consequence for non-compliance	If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
