Label review

The labeling submitted with the above letter, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) is acceptable, provided you submit one (1) copy of final printed labeling to us, with the following changes, before you ship your product.

- 1. On the Front Panel, change "WARNING" to "DANGER".
- 2. Next to "DANGER", add "POISON" (in red) and Skull and Crossbones.
- 3. Change "For Formulating Use Only" to "A Rodenticide Only for Formulation into Registered Products for Use In and Around Structures and Inside Transport Vehicles to Kill Norway Rats, Roof Rats, and House Mice." Under "Note to Physician or Veterinarian", delete "as ... overdoses.

# 4. Change the text under "WARNING" to:

Fatal if swallowed, absorbed through the skin, or inhaled. Causes moderate eye irritation. Do not get in eyes, on skin, or on clothing. Do not breathe dust. When mixing baits, use dust/mist filtering respirator (MSHA/NIOSH approval number prefix TC-21C) and wear protective clothing, protective eyewear, and rubber gloves. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

Exposure to this product during pregnancy should be avoided. Warfarin may cause harm to the fetus, including possible birth defects.

# 5. Change "PESTICIDE STORAGE" to "STORAGE".
