On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. Based on your response to the Reregistration Eligibility Decision, EPA has reregistered the product listed above. 1. Revise the statement under the product name on pages 1 and 4 to read "*Norway rats, roof rats, and house mice...*"
2. Revise your "**FIRST AID**" and "**NOTE TO PHYSICIAN OR VETERINARIAN**" texts on page 1 as follows:

FIRST AID

HAVE LABEL WHEN OBTAINING TREATMENT ADVICE

IF SWALLOWED:

- Call a poison control center, doctor, 1-877-854-2494, or 1-800-858-7378¹ [optional phone numbers] immediately for treatment advice.
- Have person sip a glass of water if able to swallow.
- Do not induce vomiting unless told to do so by the poison control center or doctor.

IF ON SKIN:

- Wash with plenty of soap and water.

IF IN EYES:

- Hold eye open and rinse slowly and gently with water for 15-20 minutes.
- Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.
- Call a poison control center or doctor for treatment advice.

NOTE TO PHYSICIAN

Anticoagulant Bromadiolone: For animals ingesting bait and/or showing poisoning signs (bleeding or elevated prothrombin times), give Vitamin K₁ at [insert dose if known]. Do not place in edible product areas of feed processing plants, restaurants or other areas where food or feed is commercially prepared or processed or place near or inside ventilation duct openings. When used in USDA-inspected facilities, this product must be applied in tamper-resistant bait stations. Do not broadcast bait.”*

URBAN AREAS: *“This product may only be used in and around homes, industrial, commercial, and public buildings; in transport vehicles (ships, trains, aircraft) and in and around related port or terminal buildings; and in alleys. Do not apply further than 50 feet from buildings. Do not use this product in sewers.”*

NON-URBAN AREAS: *“This product may only be used inside of homes and agricultural buildings.”*

5. Revise the first sentence of the **SELECTION OF TREATMENT AREAS** section to state *“Determine areas where rats or house mice...”*

6. ~~Revise the first sentence of the **RATS** subsection of the **APPLICATION DIRECTIONS** to read *“Apply 3 to 16 ounces of bait at intervals of 15 to 30 feet per placement.”*~~

7. Revise the last sentence in the **RATS** subsection of the **APPLICATION DIRECTIONS** section on pages 2 and 5 to read *“Maintain an uninterrupted supply of fresh bait for 10 days or until signs of rat activity cease to appear.”*

8. Revise the second sentence of the **MICE** subsection of the **APPLICATION DIRECTIONS** to read *“Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of mouse activity cease to appear.”*

9. Insert **HOUSE** before **MICE** under the **APPLICATION DIRECTIONS**.

10. Revise the second sentence of the **FOLLOW-UP** section in the **DIRECTIONS FOR USE** to read , *“Wearing gloves, collect and dispose...”*

11. Revise the text under **“CAUTION”** as follows:

CAUTION: Harmful if swallowed or absorbed through the skin. Keep away from children, domestic animals and pets. Causes moderate eye irritation. Do not get in eyes, on skin or on clothing. All handlers (including applicators) must wear: shoes plus socks, and gloves. Any person who retrieves carcasses or unused bait following application of this product must wear gloves.

User Safety Requirements

Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash hands thoroughly after applying bait and before eating, drinking, chewing gum, using tobacco or using the toilet and change into clean clothing.

12. Include the following statement in the **ENVIRONMENTAL HAZARDS** section: "*Dogs and predatory and scavenging mammals and birds might be poisoned if they feed upon animals that have eaten this bait.*"
13. On the individual place pack label, please add the EPA Registration Number.
14. Insert "**Pesticide**" before "**Storage**" in the **STORAGE AND DISPOSAL** section.
15. Include the following phrase in the beginning of the first sentence of the Warranty statement: "*To the extent consistent with applicable law...*"

Stocks of product with existing labels may be used for twelve (12) months. As stated under the **Terms and Conditions of Sale and Distribution** on page 35 of the Agency's revised May 28, 2008 "*Risk Mitigation Decision for Ten Rodenticides*":

- a. Product is prohibited for sale in stores oriented towards residential consumers: Grocery, Drug, Hardware and Home Improvement. It is acceptable for sale in stores oriented toward agricultural consumers: Farm, Agricultural, Tractor Stores.
- b. Product may not be sold in packaging that holds less than 16 pounds of bait.

This product is in full compliance with the Agency's revised May 28, 2008 "*Risk Mitigation Decision for Ten Rodenticides*".
