Purpose The purpose of this submission is to revise your label in accordance with PR

Notices 2001 and 2001-6.

Label review The labeling submitted with the above letter, under the Federal Insecticide,

Fungicide, and Rodenticide Act (FIFRA) is acceptable, provided you submit one (1) copy of final printed labeling to us, with the following changes, before you ship

your product.

1. Under "KILLS RATS AND MICE", modify the text as follows:

KILLS WARFARIN RESISTANT NORWAY RATS

Norway rats and house mice may consume a lethal dose in one night's feeding with first dead rodents appearing four or five days after feeding begins.

Label reviewcontinued 2. Revise your "USE RESTRICTIONS" as follows:

USE RESTRICTIONS: This product may be used to control Norway rats, roof rats, and house mice in the sites identified below for Urban Areas and Non-urban Areas. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food. When used in USDA-inspected facilities, this product must be applied in tamper-resistant bait stations. Do not broadcast bait.

Urban Areas: This product may only be used in and around (within 15 feet of) homes, industrial, commercial, and public buildings; in transport vehicles (ships, trains, aircraft) and in and around (within 15 feet of) related port or terminal buildings; and in alleys. Do not use this product in sewers.

Non-Urban Area: This product may only be used inside of homes and agricultural buildings.

3. For non-placepack products, add "Wear gloves if bait may be handled." before "Wash thoroughly with soap and water after handling."

A copy of the stamped label is enclosed for your records.

Existing stocks

Stocks of existing labels may be used for eighteen (18) months.

Consequence for non-compliance

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

READ THIS LABEL: Read this entire label and follow all use directions and use precautions.

IMPORTANT: Do not expose children, pets, or nontarget animals to rodenticides. To help to prevent accidents:

- 1. Store unused product out of reach of children and pets.
- 2. Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from bait stations when they are lifted, units must be secured or otherwise immobilized. Stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to vandalism.
- 3. Dispose of product container and unused, spoiled, or unconsumed bait as specified on this label.

USE RESTRICTIONS: For control of Norway rats, roof rats and house mice in and around homes, industrial and agricultural buildings, and similar man-made structures. Outdoor bait placements must be limited to within 15 feet of structures such as buildings, retaining walls, fence lines, streets, sidewalks, food or feed storage areas, lumber piles, trash and garbage containers or other structures providing potential food or harborage for rodents. This product may also be used in alleys located in urban areas, in sewers, inside transport vehicles (ships, trains, aircraft) and in and around related port or terminal buildings. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food. When used in USDA-inspected facilities, this product must be applied in tamper-resistant bait stations. Do not broadcast bait.

SELECTION OF TREATMENT AREAS: Determine areas where rats or mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Protect bait from rain and snow. Remove as much alternative food as possible.

APPLICATION DIRECTIONS:

Each bait block in this container weighs approximately one ounce.

RATS: Place 3 to 16 bait blocks (usually at intervals of 15 to 30 feet) per placement. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

For use in sewers, thread wire through block and securely attach to a stationary structure such as the bottom step of a manhole ladder or a sewer grate. Allow just enough wire for the block to rest on manhole benching. If benching is not present, suspend block a few inches above the high water mark or secure block on a board supported by opposing steps.

of the ladder. Securing block in this manner will prevent removal by rats or water. Use at least 15 block per manhole. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

MICE: Place 1 block per placement. Space placements at 8 to 12 foot intervals. Two blocks may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until signs of mouse activity cease.

RATS AND MICE: Replace contaminated or spoiled bait immediately. Collect and dispose of all dead, exposed animals and leftover bait. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed. Wash thoroughly with soap and water after handling.

ENVIRONMENTAL HAZARDS
