
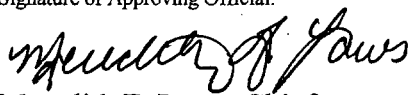

1. Revise the statement under the product names on pages 1 and 4 to read “*Norway rats, roof rats, and house mice...*”
2. Revise your “**FIRST AID**” and “**NOTE TO PHYSICIAN OR VETERINARIAN**” texts on pages 1 and 4 as follows:

FIRST AID

HAVE LABEL WHEN OBTAINING TREATMENT ADVICE

IF SWALLOWED:

- Call a poison control center, doctor, 1-877-854-2494, or 1-800-858-7378¹ [optional phone numbers] immediately for treatment advice.
- Have person sip a glass of water if able to swallow.
- Do not induce vomiting unless told to do so by the poison control center or doctor.

IF ON SKIN:

- Wash with plenty of soap and water.

IF IN EYES

- Hold eye open and rinse slowly and gently with water for 15-20 minutes.
- Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.
- Call a poison control center or doctor for treatment advice.

Anticoagulant Bromadiolone: For animals ingesting bait and/or showing poisoning signs (bleeding or elevated prothrombin times), give Vitamin K₁ at [insert dose if known]. USE RESTRICTIONS: *“For control only of Norway rats, roof rats, and house mice in the sites identified below for **Urban Areas** and **Non-urban Areas**. Do not place in edible product areas of feed processing plants, restaurants or other areas where food or feed is commercially prepared or processed or place near or inside ventilation duct openings. When used in USDA-inspected facilities, this product must be applied in tamper-resistant bait stations. Do not broadcast bait.”*

URBAN AREAS: *“This product may only be used in and around homes, industrial, commercial, and public buildings; in transport vehicles (ships, trains, aircraft) and in and around related port or terminal buildings; and in alleys. Do not apply further than 50 feet from buildings. Do not use this product in sewers.”*

NON-URBAN AREAS: *“This product may only be used inside of homes and agricultural buildings.”*

6. Insert **HOUSE** before **MICE** under the **APPLICATION DIRECTIONS** on pages 2 and 5.

7. Revise the text under **“CAUTION”** on pages 2 and 6 as follows:

All handlers (including applicators) must wear: shoes plus socks, and gloves. Any person who retrieves carcasses or unused bait following application of this product must wear gloves.

9. Insert **“Pesticide”** before **“Storage”** in the **STORAGE AND DISPOSAL** section on pages 3 and 6.
