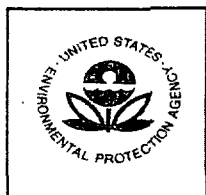

On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act. Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

Based on your response to the Rodenticide Cluster Reregistration Eligibility Decision, EPA has reregistered the product listed above. This action is taken under the authority of section 4(g)(2)(C) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. Reregistration under this section does not eliminate the need for continual reassessment of pesticides. EPA may require submission of data at any time to maintain the registration of your product.

1. Revise your "PRECAUTIONARY STATEMENTS" as follows:

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

CAUTION: Harmful if swallowed. Keep away from children, domestic animals and pets.

All handlers (including applicators) must wear shoes plus socks, and gloves. Any person who retrieves carcasses or unused bait following application of this product must wear waterproof gloves.

User Safety Requirements

Follow manufacturer's instruction for cleaning/maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash hands thoroughly after applying bait and before eating, drinking, chewing gum, using tobacco or using the toilet and change into clean clothing.

2. At the end of "**Important**" and immediately before "**Use Restrictions**", add:

Note: Bait stations are mandatory for outdoor, above-ground use. Tamper-resistant bait stations must be used if children, pests, non-target mammals, or birds may access the bait."

3. Revise the "**Use Restrictions**" as follows:

For control of ... terminal buildings. **Do not apply further than 50 feet from buildings.** Do not use in edible product areas of food or feed processing plants or other areas where food or feed is commercially prepared or processed. Do not contaminate food/feed or food/feed handling equipment or place near or inside ventilation duct openings. Do not broadcast bait. When used in USDA inspected facilities, this product must be applied in tamper-resistant bait stations.

Do not sell this product in individual containers holding less than 4 pounds of bait.

[**Note:** If you want to include field sites on this label (riverbanks, gullies, irrigation ditches, garbage dumps and landfills), you must add the following "Restricted Use Pesticide" block at the top of the Front Panel:

For retail sale to, and use only by Certified Applicators, or persons under their direct supervision and only for those uses covered by the Certified Applicator's Certification.

In this case, the product would not be subject to the May 28, 2008, Rodenticide Risk Mitigation Decision.]

4. Under "Follow-up", change "gloves" to "waterproof gloves". If your "**DIRECTIONS FOR USE**" text continues to another panel, insure that each panel has a cross-reference to the other panel with the appropriate wording.

5. Revise "RATS:" to read:

Rats: Apply 3 to 16 one-ounce bait blocks per placement. Space placements at intervals of 15 to 30 feet in infested areas. Maintain an uninterrupted supply of fresh bait for 10 days or until there no longer are signs of new feeding by rats.

When baiting sewers, securely attach one end of wire to each block and the other end to a stationary structure such as the bottom step of a manhole ladder or a sewer grate. Allow just enough wire for the block to rest on manhole benching. If benching is not present, suspend each block a few inches above the high water mark or secure block on a board supported by opposing steps of the ladder. Securing blocks in this manner will reduce chances that they will be removed by rats or water. Use 3 to 16 blocks per manhole, depending upon the apparent intensity of rat activity. Maintain an uninterrupted supply of fresh bait for at least 10 days or until there are no signs of new feeding by rats.

- 6. All final printed labels of this product, including distributor labeling, such as Motomco, must be easily read and have the same organization structure. All labels must conform to the enclosed "Minimum Type Size Requirements for Final Print Labels", including text on a contrasting background.
- 7. According to your September 2, 2008, amended application form, you package this product in "plastic" and "paper". Use the following text to revise your "**STORAGE AND DISPOSAL**" text according to PR Notice 2007-4:

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store only in original container in a cool, dry place inaccessible to children and pets. Keep containers closed and away from other chemicals.

Pesticide Disposal: Dispose of wastes resulting from the use of this product in trash or at an approved waste disposal facility.

Container Handling: Nonrefillable container. Do not reuse or refill this container. **[Plastic:]** Triple rinse (or equivalent) then offer for recycling or reconditioning; or puncture and dispose of in a sanitary landfill; or incineration. In most states, burning is not allowed. **[Paper]** Dispose of empty container by placing in trash, at an approved waste disposal facility or by incineration. In most states, burning is not allowed.

- a. Product is prohibited for sale in stores oriented towards residential consumers: Grocery, Drug, Hardware and Home Improvement. It is acceptable for sale in stores oriented toward agricultural consumers: Farm, Agricultural, Tractor Stores.
- b. Product may not be sold in packaging that holds less than 4 pounds of bait.

The acceptable Confidential Statement of Formula (CSF) for this product is dated **August 6, 2003**. All other versions are obsolete.

Stocks of product with existing labels may be used until June 4, 2011.

This product is in full compliance with the Agency's revised May 28, 2008 "Risk Mitigation Decision for Ten Rodenticides".

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

READ THIS LABEL: Read this entire label and follow all use directions and use precautions. Use only for sites, pests, and application methods described on this label.

IMPORTANT: Do not expose children, pets, or nontarget animals to rodenticides. To help to prevent accidents:

1. Store unused product out of reach of children and pets.
2. Bait stations are mandatory for outdoor, above ground use. Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from bait stations when they are lifted, units must be secured or otherwise immobilized. Stronger bait stations are needed in areas open to hooved livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to vandalism.
3. Dispose of product container and unused, spoiled, or unconsumed bait as specified on this label.

USE RESTRICTIONS: For control of Norway rats, roof rats and house mice in and around homes, industrial, commercial, agricultural, and public buildings, and similar man-made structures. May also be used in transport vehicles (ships, trains, aircraft) and in and around related port or terminal buildings. This product is especially suited for wet or damp areas, such as riverbanks, gullies, irrigation ditches, sewers, garbage dumps and landfills. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food. When used in USDA-inspected facilities, this product must be applied in tamper-resistant bait stations.

Do not sell this product in individual containers holding less than 4 pounds of bait.

SELECTION OF TREATMENT AREAS: Determine areas where rats or mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Protect bait from rain and snow. Remove as much alternative food as possible.

APPLICATION DIRECTIONS:

RATS: Place 3 to 16 bait blocks (usually at intervals of 15 to 30 feet) per placement. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

For use in sewers, thread wire through block and securely attach to a stationary structure such as the bottom step of a manhole ladder or a sewer grate. Allow just enough wire for the block to rest on manhole benching. If benching is not present, suspend block a few inches above the high water mark or secure block on a board supported by opposing steps of the ladder. Securing block in this manner will prevent removal by rats or water. Use at least 15 blocks per manhole. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

MICE: Apply 1 block per typical placement. Space placements at 8 to 12 foot intervals. Two blocks may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until signs of mouse activity cease.

FOLLOW-UP: Replace contaminated or spoiled bait immediately. Using gloves, collect and dispose of all dead, exposed animals and leftover bait. To prevent reinfestation, limit sources of rodent food, water,

and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

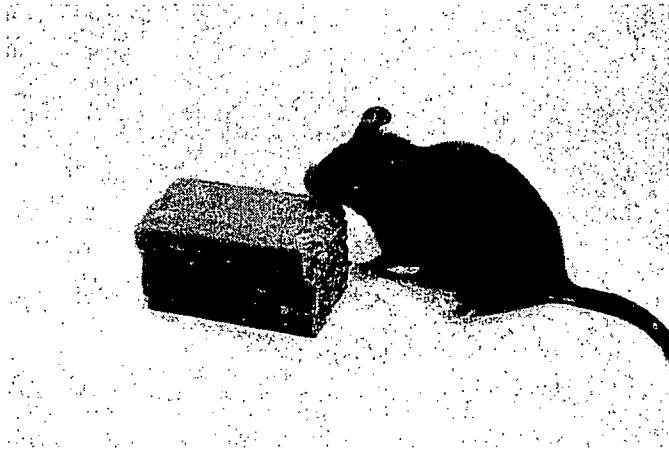
