IMPORTANT: Do not expose children, pets, or nontarget animals to rodenticides. To help to prevent accidents:

- 1. Store unused product out of reach of children and pets.
- 2. Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. MICE: Apply 1 pac per placement. Space placements at 8 to 12 foot intervals. Two pacs may be applied at points of extremely high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there no longer are signs of fresh mouse activity.

FOLLOW-UP: Replace contaminated or spoiled bait immediately. Collect and dispose of all dead, exposed animals and leftover bait. To prevent reinfestation, limit sources of

rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.
