c. Revise your “**FIRST AID**” and “**NOTE TO PHYSICIAN OR VETERINARIAN**” text as follows on Pages 1 and 4:

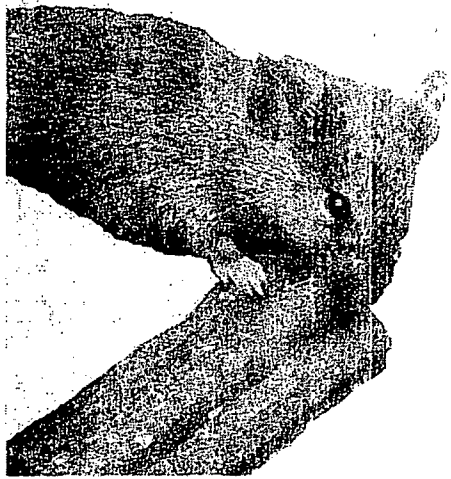
