- j. Insert **"Pesticide"** before **"Storage"** in the **STORAGE AND DISPOSAL** section on Pages 3 and 6.
- k. On Page 3 of the **WARRANTY** statement, add a period after the last sentence. In addition, on Page 6 in the **WARRANTY** statement, add *"instructions"* to the end of the last sentence.
  - 1. Make the following changes to the marketing claims:
    - Revise *"Mouse and rat bait"* to read *"House mouse and rat bait"*
    - Revise *"For indoor & outdoor rodent control"* to read *"For indoor & outdoor control of Norway rats, roof rats, and house mice."*
    - Remove *"rodents"* from the claim beginning with *"Place pacs fit easily into rat burrows..."* and replace with *"they"*.
  - 3. Storage stability (830.6317) and corrosion characteristics (830.6320) data must be submitted within 18 months.
  - 4. As stated under the **Terms and Conditions of Sale and Distribution** on page 35 of the Agency's revised May 28, 2008 *"Risk Mitigation Decision for Ten Rodenticides"*:
    - a. Product is prohibited for sale in stores oriented towards residential consumers: Grocery, Drug, Hardware and Home Improvement. It is acceptable for sale in stores oriented toward agricultural consumers: Farm, Agricultural, Tractor Stores.
    - b. Product may not be sold in packaging that holds less than 8 pounds of bait.
  - 5. This product is in full compliance with the Agency's revised May 28, 2008 *"Risk Mitigation Decision for Ten Rodenticides"*.
