The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

This product is extremely toxic to fish, birds and other wildlife. Dogs, cats and other predatory and scavenging mammals and birds might be poisoned if they feed upon animals that have eaten this bait. Do not apply directly to water.

USE RESTRICTIONS:

This bait station may be used in areas accessible to children and pets, consistent with all use restrictions and other requirements indicated on this label. Do not apply further than 50 feet from home or building.

For control only of house mice. This bait station can only be refilled with the block bait sold with this station. Tomcat® Mouse Killer I [This Product] must be used in and around buildings consistent with all use restrictions and other requirements indicated on this label. Do not place this bait station or stored block bait in any area where there is a possibility of contaminating food or surfaces that come into direct contact with food. Store block bait refills out of reach of children and pets.

SELECTION OF TREATMENT AREAS [Indoors & Outdoors]: Determine areas where house mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in corners and concealed places.

APPLICATION DIRECTIONS:

While wearing waterproof gloves, place one block of bait in the bait station. See additional GRAPHICS AND TEXT. Place the bait station at point of highest activity along a wall or in corner where signs of house mice have been seen. If additional units are to be used, place bait stations at 8- to 12-foot intervals. [To monitor for refilling view bait via see-through lid.] While wearing waterproof gloves, replace bait in bait station if bait is consumed or contaminated and house mice still are using the bait station. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there no longer are fresh signs of house mouse activity in infested areas. [Note: Mice will eat a small amount of bait and leave the station. You likely will not find a dead mouse in the station.] / [Note: Mice will eat a small amount of bait and cease feeding after consuming a toxic dose. They then leave the station. You likely will not find a dead mouse in the station.]

1 REMOVE BAIT CARTRIDGE FROM BOTTOM OF STATION



With your left hand push tab up.



While still holding tab, squeeze prongs of bait cartridge and pull away from station.

2 LOAD BAIT



Place bait into cartridge.



Push cartridge into station until it clicks into place.

Follow-up: Wearing waterproof gloves, collect and properly dispose of any leftover bait or carcasses. To discourage reinfestation, eliminate food, water and harborage as much as possible. If reinfestation does occur, repeat treatment.

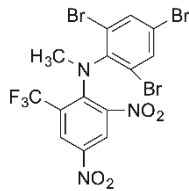
