- c. Make the following revisions to the "OPTIONAL MARKETING STATEMENTS" section:
  - a. Delete "Rodent" from "Mouse/Rat/Rodent feeding station."
  - b. Delete "No need to touch the bait."
  - c. Delete "Bait sealed inside station."
- d. Make the following deletion to the "OPTIONAL GRAPHICS" section:
  - a. Remove the image of the rat eating the bait block.
- 3. As stated in 40CFR156.140(a)(4), a batch code must be included on the label or package for container and containment for nonrefillables.
  - 4. Should you wish to add a reference to the company's website on your label, please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process.   - 5. This product is not consistent with the Agency's revised May 28, 2008 "Risk Mitigation Decision for Ten Rodenticides." EPA anticipates cancellation of those existing products that are not consistent with the Risk Mitigation Decision to occur no later than June 4, 2011. In the meantime, EPA is approving new registrations and amendments to existing registrations of rodenticide bait products, on a time-limited basis, so long as the registrations do not present greater risks of unreasonable adverse effects than existing products. Accordingly, this amendment is approved only subject to the condition that the registration shall expire on June 4, 2011. This condition of registration may be amended in conjunction with amendments to conform to the Risk Mitigation Decision. Absent such amendments, product released for shipment by the registrant after June 4, 2011, would be in violation of FIFRA.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

#### **DIRECTIONS FOR USE**

#### **USE RESTRICTIONS:**

DO NOT USE THIS PRODUCT OUTDOORS OR IN AREAS ACCESSIBLE TO CHILDREN, PETS, DOMESTIC ANIMALS, OR NONTARGET WILDLIFE.

For control only of rats and house mice inside of homes. TOMCAT RAT KILLER bait station must be used in homes consistent with all use restrictions and other requirements indicated on this label. Do not place this bait station in any area where there is a possibility of contaminating food or surfaces that come into direct contact with food.

**SELECTION OF TREATMENT AREAS:** Determine areas where rats and/or house mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in corners and concealed places.

#### APPLICATION DIRECTIONS:

Place the TOMCAT RAT KILLER bait station at highest point of activity along a wall or in corners where rats and/or mice or their signs have been seen. If additional units are purchased, place bait stations at 15 to 30 foot intervals. Maintain a constant supply of fresh bait for 10 days or until signs of rat or mouse activity cease in infested areas. Replace bait stations if contents are consumed or contaminated.

**Follow-up:** While wearing gloves, collect and dispose of emptied bait stations and all dead animals. To discourage reinfestation, eliminate food, water and harborage as much as possible. If reinfestation does occur, repeat treatment.

## PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Keep away from humans, domestic animals, and pets. Bait block contents harmful if swallowed or absorbed through the skin. Do not get in eyes, on skin or clothing. Any person who retrieves carcasses or unused bait following application of this product must wear gloves.

Sublethal symptoms, if present, would be the result of cerebral edema and should be treated accordingly through administration of an osmotic diuretic and corticosteroid.






