**SELECTION OF TREATMENT AREAS:** Determine areas where rats or house mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in corners and concealed places.

**APPLICATION DIRECTIONS:**

Place the TOMCAT RAT KILLER I bait station at highest point of activity along a wall or in corners where signs of rats or house mice have been seen. If additional units to be used, place bait stations at intervals of 15 to 30 feet for rats and 8 to 12 feet for mice. Maintain a constant supply of fresh bait for 10 days or until there no longer are signs of rat or mouse activity. Replace bait stations if contents are consumed or contaminated.

**Follow-up:** While wearing gloves, collect and dispose of emptied bait stations and all dead animals. To discourage reinfestation, eliminate food, water and harborage as much as possible. If reinfestation does occur, repeat treatment.
