



APPLICATION DIRECTIONS:

Place one bait block in the bait station. See additional GRAPHICS AND TEXT. Place the bait station at highest point of activity along a wall or in corner where mice or their signs have been seen. If additional units are to be used, place bait stations at 8 to 12 foot intervals. While wearing gloves, replace bait in bait station when bait is consumed or contaminated. Maintain an uninterrupted supply of fresh bait for at least 15 days or until signs of mouse activity cease in infested area.

LOADING BAIT INTO STATION







Follow-up: Wearing gloves, collect and dispose of any leftover bait. To discourage reinfestation, eliminate food, water and harborage as much as possible. If reinfestation does occur, repeat treatment.


