Dear Ms. Vingum:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or

claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

If, after formal consultation with the appropriate Service(s), additional modifications are identified in the Service's Biological Opinion(s) for Zinc Phosphide, EPA will notify Bell in writing consistent with the terms in the Biological Opinion of any necessary required changes. Bell must submit an application for amendment incorporating any required changes, including amended labels, consistent with the timeline specified in EPA's notification. If Bell fails to comply with this term, Bell has agreed in prior written acceptance of these terms on May 28<sup>th</sup>, 2025 that EPA may cancel the registration under an expedited process under FIFRA 6(e).

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6.

#### NOTE TO PHYSICIAN OR VETERINARIAN

Contains the phosphine-producing active, Zinc Phosphide. Probable mucosal damage may contraindicate the use of gastric lavage. For animals ingesting bait and/or showing poisoning signs, induce vomiting by using hydrogen peroxide. Sodium bicarbonate can be given orally to neutralize the stomach acidity. The stomach and intestinal tract can be evacuated, oxygen administered and cardiac and circulatory stimulants given.

#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. **READ THIS LABEL:** Read this entire label and follow all use directions, restrictions and precautions.

#### **USE RESTRICTIONS:**

- Do not apply by any method, to any pest, or to any site not specified on this label.
- Only apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife. Tamper-resistant bait stations must be used if children, pets, non-target mammals, or birds may have access to the bait placement location. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from bait stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears, other potentially destructive animals, or in areas prone to vandalism.
- Bait stations are mandatory for outdoor, above-ground use.
- Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. Keep all persons out of the treated area during application.

This product may only be used to control the following rodent pests in and around man-made structures: House mouse (*Mus musculus*), Norway rat (*Rattus norvegicus*), Roof rat (*Rattus rattus*), Cotton rat\* (*Sigmodon hispidus*), Eastern harvest mouse\* (*Reithrodontomys humuli*), Golden mouse\* (*Ochrotomys nuttalli*), Polynesian rat\* (*Rattus exulans*), Meadow vole\* (*Microtus pennsylvanicus*), White-throated woodrat\* (*Neotoma albigula*), Southern plains woodrat\* (*Neotoma micropus*), and Mexican woodrat\* (*Neotoma mexicana*). This product must be used in and within 100 feet of man-made structures constructed in a manner so as to be vulnerable to commensal rodent invasions and/or

to harboring or attracting rodent infestations. Examples of such structures include homes and other permanent or temporary residences, food processing facilities, industrial and commercial buildings, trash receptacles, agricultural and public buildings, transport vehicles (ships, trains, aircraft), docks and port or terminal buildings and related structures around and associated with these sites. Fence and perimeter baiting, beyond 100 feet from a structure as defined above, is prohibited. This product must not be applied directly to food or feed crops.

This product may be applied to active rodent burrows to control rats within or beyond 100 feet of buildings and man-made structures, provided that infestations of these rodents have been confirmed. Bait must be placed no less than 6 inches into active rat burrows. Do not broadcast bait. Because rat infestations may occur in areas farther than 100 feet from buildings and man-made structures when the rodents have ample supplies of food and cover, efforts should be made to remove food trash, garbage, clutter and debris.

Do not place bait near or inside ventilation duct openings. Do not contaminate water, food, feedstuffs, food or feed handling equipment, or milk or meat handling equipment or surfaces that come into direct contact with food. When used in USDA inspected facilities, this product must be applied in tamper-resistant bait stations.

Do not sell this product in individual containers holding less than 4 pounds of bait.

#### **APPLICATION DIRECTIONS:**

**SELECTION OF TREATMENT AREAS:** After removing as many sources of food and water as possible, determine dry, acid-free areas where rats, mice or meadow voles\* will most likely find and consume the bait. Generally these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where signs of rats, mice, meadow voles\* have been observed.

**APPLICATION DIRECTIONS FOR RATS**: Apply 1 to 2 teaspoon amounts of bait per placement. For outdoor use, place bait in active rat burrows or tamper-resistant bait stations. Maintain an uninterrupted supply of fresh bait until all signs of feeding on bait have stopped. Do not treat the same area at less than 30 day intervals.

**APPLICATION DIRECTIONS FOR MICE AND MEADOW VOLES\***: Apply 1 teaspoon of bait per placement at intervals of 8 to 12 feet. For outdoor use, place bait in tamper-resistant bait stations. Maintain an uninterrupted supply of fresh bait until all signs of feeding on bait have stopped. Do not treat the same area at less than 30 day intervals. Collect and dispose of all dead animals.

**FOLLOW-UP:** Wearing waterproof gloves, collect and dispose of dead, exposed animals. Dispose of leftover bait in accordance with disposal instructions. Use detergent and hot water to wash spoons used for application into burrows. Do not use spoon for mixing, holding or transferring food or feed. To discourage reinfestation, limit sources of rodent food, water, and harborage as much as possible.

# PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

Harmful if swallowed or inhaled, causes moderate eye irritation, avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet. Wear long sleeved shirt and long pants, shoes plus socks and gloves. Remove and wash contaminated clothing before reuse. Any person who retrieves carcasses or unused bait following application of this product must wear gloves.

- Remove clothing/PPE immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing.
- Remove PPE immediately after handling this product. Wash the outside of gloves before removing them. As soon as possible, wash thoroughly and change into clean clothing.
