

DIRECTION FOR USE
General Classification

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

When used as directed, it will kill and prevent development of *Chlorella pyrenoidosa* (green), *Phormidium mundatum* (black algae), *Phormidium retzii* (Square D algae), *Lyngbya versicolor* (blue-green) and other swimming pool algae.

INITIAL APPLICATION: To a cleaned pool add one gallon to 50,000 gallons of water, or ratio thereof.

MAINTENANCE DOSE: Use one quart per 50,000 gallons of water, every 5 to 7 days. Use this dosage immediately after heavy rain. When weather is hot or bathing load is heavy, use this dosage every 5 days or as necessary.

WINTER USE: Add to a cleaned pool at the rate of one gallon to 50,000 gallons of water, before filter shut down at end of swimming season. Allow to circulate. Cover the pool after application. Repeat treatment above with no filter agitation 4 to 6 weeks before resuming daily pool operation.

PRECAUTIONARY STATEMENTS

DANGER

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

Corrosive: Causes severe eye and skin damage. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful or fatal if swallowed. Avoid contamination of food.

PRACTICAL TREATMENT: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse. If swallowed, drink promptly, a large quantity of milk, egg whites, gelatin solution; or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, as well as oxygen and measures to support breathing manually or mechanically may be needed.

ENVIRONMENTAL HAZARDS

This product is toxic to fish. Do not discharge into lakes, streams, ponds or public waters unless in accordance with an NPDES permit. For guidance contact your regional office of the EPA.

PHYSICAL OR CHEMICAL HAZARDS

Compatible with most commonly used swimming pool chemicals but should not be mixed with soap or other cleaners or premixed with other water treating chemicals. Works best when added by itself directly to pool water. Use dilution is non-corrosive to inanimate surfaces.

Do Not reuse empty container. Wrap container and put in trash collection.
